2014 PwC Moy/ Houng-Lee Scholarship Application Form

Who should apply?

You are a bright young Fiji citizen:

- who possesses a good academic record;
- who wants to pursue a career in accounting;
- who is well rounded, as evidenced by your community involvement, sporting or extra-curricular activities;
- who is of good character and integrity;
- who is ambitious; and
- committed to your goals.

You should possess at least a 300 total pass (including accounting, english and maths) in Fiji Seventh Form Examination or completed a Foundation Programme with at least a 2.5 GPA.

What are you applying for?

You are applying for a scholarship which will at least cover the full cost of your tuition fees to complete a Bachelor Degree relating to Accountancy at the University of the South Pacific. The successful applicant may also receive financial support towards the cost of his/her accommodation and a general living allowance.

Eligibility

You are eligible to apply if:

- you are a Fiji citizen;
- you are in your last year of high school or Foundation Programme at the USP; and
- your parent's annual gross joint income does not exceed FJD 20,000.

You cannot apply for a scholarship if:

- You are a PwC employee or a close relative of a PwC employee.
- You are already enrolled in a degree programme and you are already in the first year of the course.

The degree programme undertaken must correspond to one of the following fields of study:

- Bachelor of Commerce
- Bachelor of Arts with a major in Accounting
- Bachelor of Arts with a double major in Accounting & Economics
- Bachelor of Arts with a double major in Accounting & Information Systems

The successful candidate must be accepted by the University of the South Pacific to begin his or her course in 2014 and submit the certification of acceptance by the latest 15 January, 2014. If the successful candidate cannot meet this requirement the scholarship will be awarded to the runner-up.

When?

Your application must be received at the PwC office by Friday, 27 September 2013. We will review all application packages and interview potential candidates in late October 2013. If you are unsuccessful, you will receive notification by mail or email.

How?

Here is what you need to include in your application package (in the following order):

1. Complete the details in the form below.
2. Cover letter giving details of your background, career aspirations and community involvement, and why you consider yourself deserving of the PwC Moy/Houng-Lee scholarship.
3. An official high school or university (Foundation) transcript of your most recent academic year which includes GPA and exam score, as applicable.
4. Two character references (*Please ensure that the references are current and from two different non-family sources*)
5. Proof of Fiji citizenship.
6. Certified Birth Certificate.
7. Detailed Resume/CV (with photograph), accompanied by any certified certificates.
8. Proof of your parent's joint annual income.
